PROMISSORY NOTE

For a valuable consideration, the receipt and sufficiency of which is hereby acknowledged, we or either of us, as principals, promise to pay to the order of Bobby Davis Bail Bonds, in the city of Fort Worth, Texas 76102, Tarrant County, Texas, the sum of _____ and 00/100 dollars (\$ _____ .00), in legal money of the United States of America, with interest thereon at the rate of ten percent (10%) per annum from date until paid.

Indemnitor and Defendant agree to pay Bobby Davis Bail Bonds a 10% per annum for this bail bond. This bond is renewable each year. Indemnitor and Defendant agree to pay Bobby Davis Bail Bonds a renewal premium in the amount of 10% of the face amount of the bond(s), twelve months after the date on which this bond was executed. If said renewal premium is not paid upon written demand, Surety has the right to surrender Principal, and exonerate the bond.

It is expressly agreed and provided that upon default in the punctual payment of this note when it becomes due and payable (punctual payment shall mean not to exceed five days after the note becomes due and payable as provided above) then an additional sum as reasonable collection fees shall be added to said principal and interest, and further, if the same is placed in the hands of an attorney for collection, then the undersigned agree and promise to pay an additional sum as a reasonable attorney's fee, which in no event shall be less than forty percent (40%) of the principal and interest then owing.

It is expressly agreed and provided that after this note becomes due and payable, the holder hereof may agree with any of us to accept partial payments in installments and such agreement or payments shall not affect the liability of the other makers who shall remain bound for the payment thereof. Venue of any action on this note shall be in Tarrant County, Texas.

It is expressly agreed and provided that if suit is necessary for collection of this note, the holder hereof may sue any or all of the undersigned and any party not served with citation therein shall not be released but remain bound for the payment hereof.
